# a/ The "Dealing with Discounts Details" Constitutional Motion

Proposer: Leo Nasskau Seconded: Isabel Pearse

## This JCR notes that:

**a.** Section 1.i.i of Standing Order Table 2 obliges the Discounts Officer to 'distribute a discount card to all new JCR members'.

- **b.** Section 1.i.ii of Standing Order Table 2 obliges the Discounts Officer to 'distribute them (the JCR Discount Card) to anyone who has paid the sum of £5 to the JCR scheme.'
- **c.** The website www.sjcdiscounts.com states that 'it (the Card) is available for students at St John's College, Oxford, as well as other Oxford colleges.'
- **d.** In Hilary Term 2009, a Discounts Card was distributed to all JCR members free of charge and cost £2 to replace.
- e. Today, a new Card costs £5 whilst a replacement card costs £3.
- **f.** One Card will cost no more than 20p to produce.

#### This JCR believes that:

- **g.** Those who have 'paid the sum of £5' for the Card are not necessarily those who are 'new JCR members'.
- **h.** Those who have 'paid the sum of £5 to the JCR scheme' are not necessarily those who attend St John's College or 'other Oxford colleges'.
- **i.** This creates a constitutional confusion whereby the Discounts Officer is *de jure* obliged to perform contradictory roles, at least one of which, logically, is impossible.
- **j.** This makes the role kinda tough.
- **k.** Charging £5 for a new Card and £3 for a replacement is an unnecessary burden upon students seeking to save money.
- I. The Discounts Card should be distributed to all members of the JCR for free, to all those from other Oxford colleges that request one for £2, and all should pay a £2 replacement fee to replace a Card.
- m. The Discounts Officer has a budget of £100 which could easily shoulder the cost of procuring Cards

#### This JCR therefore resolves to:

n. Replace Section 1.i.ii of Standing Order Table 2:

Advertises the Discount Card scheme at the annual Freshers' Fair, creating and distributing them to anyone who has paid the sum of £5 to the JCR scheme.

With:

Advertises the Discount Card scheme at the annual Freshers' Fair, creating and distributing one Card each to all those who are either JCR/MCR members or members of other Oxford colleges who have paid £2 to the JCR Scheme, whilst maintaining a list of all those to whom a Card has been delivered.

**o.** Create a Section 1.i.viii of Standing Order Table 2 stating that:

Is obliged in the event of a Card needing replacement to deliver a Card to anyone who fulfils the following criteria: they have requested a Card; they are on the list of those to whom a Card has been delivered; and they have paid the sum of £2 to the JCR scheme as a replacement fee.

#### v/ Items for Discussion

• JCR Meeting Schedule - Joe Sisson, JCR President

Joe Sisson noted that in general the 3rd meeting of every term in his experience is poorly attended. He noted there was an issue with Charities getting money and motions needing to be passed, but wanted to know what the floor thought. Cas Burton noted it is important that there is a meeting so they can pass an emergency expenditure motion, such as the recent need to repay the Art Reps who spent £200 to repair a damaged art frame. Joe suggested a stronger contingency in budgets for emergency expenditure. Chris Hughes noted that 3 meetings per term could be considered by the 2019 JCR, but we cannot account for the future interest from the next JCRs.

Alfie Deere-Hall noted having the JCR meeting on a different day of the week could increase turnout, with Wadham having a Wednesday meeting and getting high turnout. Joe noted a survey undertaken in 2018 found that Sunday evening was the most convenient time for people to attend by a "substantial plurality". Joe suggested that an alternating day would allow different segments of the JCR to attend. Tom Johnson asked for Alfie's reasoning, to which he replied that people are a "bit dead" on a Sunday, so a possible early Friday evening would serve well as an early pre-drinks. Tom Johnson noted some friends asked about having wine at the JCR, to which Greg replied that wine would be beneficial to the JCR experience. Alfie suggested having a trial JCR meeting doubling as a Bridge Thursday pre-drinks would increase attendance. Cas noted that they would be less likely to attend if alcohol became the theme of the JCR, and asked the PRAT reps to buy soft drinks as well for all future JCR meetings. Joe opted to send out a survey on the best time and days.

- Constitutional Appendices Benedict Gardner, JCR Secretary
  Benedict Gardner updated the Constitution. Harry asked about the equipment appendices, but Joe noted that this is just an itinerary rather than a mandate to loan equipment, and so should be deleted. Benedict to delete.

• Standing Policy Items to be Removed - Benedict Gardner, JCR Secretary
Benedict noted that the following motions (linked above) would be removed. Alfie raised problems with
the removal of Frubes. Tom took the chance to let the JCR know PRAT used to stand for Person
Responsible for Alcohol and Tobacco, then PRA(Toys). Benedict read out the following Motions to be
removed, with Joe Sisson noting little progress made on either the 24 Hour Gym or the extra machine.
The First Responder Motion was no longer relevant, and Benedict informed the room that the "This JCR
Needs More Female Leaders" Motion would expire before the next meeting (on 25/02/19).

# vi/ Agenda Items

# a/ The "Budget Reallocation" Financial Motion

Proposer: Cas Burton, JCR Treasurer Seconded: Ben Gardner, JCR Secretary

## This JCR notes that:

- a. The Treasurer has the responsibility of ensuring that the Budget is spent efficiently and with the aim of maximising the overall benefit of this money for the members of the JCR.
- b. The Treasurer is mandated to bring Budget Reallocation Motions to prevent overspending in particular Budget Areas, whilst ensuring that the overall expenditure remains constant.
- c. After the last budget was passed, new information came to light with regard to the Secretary's expenditure. This new information being the increase in costs of termicard printing.

- d. After the last budget was passed, new information came to light with regard to the Bike Rep's expenditure. This involves expanding the bike scheme.
- e. After the last budget was passed, new information came to light with regard to Art Rep's expenditure. This involves repairing the frame of one of the paintings.
- f. The Expenditure Carried Forward budget has been used by people who were yet to be reimbursed from last term, so is now being used to increase the expenditure for those who need it.

#### This JCR believes that:

g. The <u>Budget</u> should appropriately account for all expected expenditure.

#### This JCR therefore resolves to:

- h. Increase the Secretary's budget from £100 to £120.
- i. Increase the Bike Rep's budget from £2,250 to £2,600.
- j. Increase the Art Rep's budget from £150 to £500.
- k. Decrease the Expenditure Carried Forward budget from £2000 to £1280

Cas asked for to pay the motion that she can pay people back money owed. Benedict took the chance to inform the JCR that there are 5 new bikes secured by the him and Bike Rep Sebastian Towers (not present). Benedict thanked Cas for their support with the funding.

## b/ The "Be My Bop Angel" Constitutional Motion

Proposer: Harry Sugden (Entertainment Officer) Seconded: Bridget Stuart (Entertainment Officer)

# This JCR notes that:

- a. First Responder training has been discontinued by the Oxford SU following advice received regarding its unsuitability (students dealing with first disclosures), and after becoming aware that the training had been used by colleges at Bops as supervision.
- b. The new 'Bystander Intervention' training is, as stipulated by the SU, not a replacement for First Responder training in order to provide Bop supervision.
- c. Communication between College Welfare Staff has now resolved the unsuitable requirement at Bops, with a new requirement for supervision in the form of what we have named 'Bop Angels'.
- d. The role of the 'Bop Angel' is to inform the porters of any incident that arises at Bop and to assist where necessary.
- e. Without a full rota of 'Bop Angels', a Bop cannot go ahead.

### This JCR believes that:

- f. Any references to First Responder training in the Constitution should be removed.
- g. (Almost?) nobody wants Bop to be cancelled due to a lack of willing 'Bop Angels'.
- h. The Entertainment Officers should primarily focus efforts on filling the rota with the help of the wider JCR, in return for an incentive (i.e. free Bop Juice).

i. There should be some sort of fall-back to ensure that if the rota is not filled, Bop can still go ahead. This will be recorded such that a fair rotation between JCR General Committee members is achieved.

#### This JCR therefore resolves to:

j. Remove clause vi. from Standing Order Table Two, Section 1.r. referring to the requirement for the Women's Officer to undertake First Responder Training

"Must undertake First Responder training within one term of taking office, if not already qualified as such."

k. Add (as clause viii.) to Standing Order Table Two, Section 1.k. the following:

"Organise appropriate supervision for the duration of Bops (in the form of 'Bop Angels'), with the assistance of JCR General Committee members where slots remain unfilled."

Harry asked for the Constitutional Motion to be added in case people don't sign up to be Bop Angels from the wider JCR, JCR Committee members will be drafted in to ensure the Bop can go ahead. Chris noted his concern with having to go to a Bop, or whether a future JCR Committee may have a similar attitude to Bops, but Joe noted that in reality the Entz Officers will not force anyone to go against their will. Harry also included that Bop Angels would not have to enter the Kendrew Events Room itself, and need no formal training.

Cas asked whether a breakout room/welfare space for the JCR, with Maddie Leggett noting that some Bops at other Colleges have calmer rooms. Harry noted this is difficult because the room would have to be staffed by students, which is difficult due to existing shortages.

Joe asked for this to be moved to a later date. On a separate note, Alfie asked about the role of the Junior Deans, with Greg replying that they tend not to get involved with welfare issues. Joe noted there were issues with Junior Deans during Freshers Week, which Joe is planning to raise.

## c/ The "Let's Make a Website" Constitutional Motion

Proposer: Benedict Gardner, JCR Secretary

Seconded: Hannah Pook

## This JCR notes that:

1. St John's JCR currently has a rusty, outdated website

2. In 2018 Rents and Charges Committee negotiated £1000 for the website to be rebuilt

#### This JCR believes that:

1. Having a working website is important for the convenience of JCR members, and our image to potential students applying

2. This money has been ring fenced and should therefore be spent in the lifetime of this Committee

#### This JCR therefore resolves to:

1. Insert in Standing Table 8 (as 2e) the following:

#### e/ The JCR Website Sub-Committee

i.The JCR Website shall be formed and disbanded at the discretion of the Secretary, and the Secretary shall serve as Chair.

ii. Where the position of Secretary is vacant, and the Sub-Committee is formed, the President shall serve as Chair.

iii. The Chair may appoint to the Sub-Committee any JCR member in any role that they see fit to create.

iv.Any person, other than the Chair, shall be removed from the Sub-Committee after notification, from the Chair, of removal from the Sub-Committee.

Benedict noted that £1000 was negotiated by Joe, CJ and the 2018 Rents and Charges Team, which needed to be spent. Benedict would be Chair of this, and will advertise positions in the upcoming week (wb 11/02/19). He noted that no coding experience was required, so direction is more needed in layout and content to improve the old, creaky website currently in use.

Chris asked how much influence College has in the process. Benedict answered that there would be none, with this being directed by the JCR. Joe noted that we can use this freedom to make this more Outreach focussed, to get the most utility out of the website (with few JCR members using the website, and only engaging for reference materials). The website will still serve as a place for reference materials, but Access focus will be built in. Issy Stephens (Social Media Rep) asked about the distinction in purpose between this and the Social Media Outreach, to which Joe replied that the social media will continue its Access role independently, confined to social media channels, which will still be important for the future.

Lachlann asked about domain space from the College, noting the the John's JCR do not use the College's domain space. Joe noted that this is a limiting presence, meaning the JCR would have to conform to college's policies, meaning the JCR would have to use Single Sign On, and allows the college to moderate content, which the IT Support Staff at John's advised the JCR against using. Cas noted that getting any content on the John's current domain space is difficult, noting they experienced significant difficulties getting things past college because of the large vetting process. Issy raised similar concerns, suggesting that the less put under the College's domain the better, based on her experience with the Women's Network not being put under the College banner. Harry asked whether SSO could be integrated without use of College's domain space. Joe stated that yes, but this would be even more limited and would require using the University's IT infrastructure, which is "quite frankly hideous", and the IT Staff at College advised against. Chris asked about the College Intranet, which according to Joe exists and looks "quite good", but is not yet ready. Joe saw this in Michaelmas 2017 and it is still not ready for use, which indicates how long these IT projects take. The JCR's website will be separate in content, including room ballot. Cas requested to have content published about Transgender support information and support on the new website.
